TERMS AND CONDITIONS

Tropfest Terms and Conditions of Ticket Sales and Entry for Corporate Hospitality Packages and Patrons

The following terms and conditions apply to all sales by Tropfest (or any sales agent) of Corporate Experiences for the Tropfest 25 Festival.

1. Ticketing

- a. In consideration for Your payment of the fees as specified in the corporate hospitality booking form, Tropfest will provide the Corporate Experience Option.
- b. All fees must be paid by You with an immediate 10% deposit payable with the submission of the Booking Form and the balance payable by Friday 30th January 2017 or at a time as agreed with Tropfest.
- c. All bookings and ticket purchases are non-refundable and non-transferable and may not be sold or transferred by You or Your Corporate Patrons.
- d. Tropfest 25 is an all-weather event. No refunds will be made if You choose not to attend or leave early due to inclement weather.

2. Tropfest 25

Tropfest reserves the right to:

- a. revise Tropfest 25's content; and/or
- b. cancel or postpone Tropfest 25 for any reason. In the event of the cancellation in advance of Tropfest 25, Tropfest will provide a refund less an amount to cover the cost of ticketing.

3. Entry and Conduct

- a. The right of admission is reserved and is subject to these Terms and Conditions.
- b. Tropfest 25 is open to all ages. Children under the age of 15 years that attend Tropfest 25 must be supervised by a responsible adult (in accordance with liquor laws and regulations) at all times.
- c. If required or on demand Corporate Patrons must provide identification to prove they are over the age of 18 years old.
- d. You must ensure that Your Corporate Patrons and invitees act in an orderly manner when attending the Event. Anyone who behaves in an intoxicated, disorderly, disruptive, offensive, threatening or inappropriate manner, towards any person may at the sole discretion of Tropfest be refused entry or required to leave.
- e. It may be a condition of entry to the Event that a personal search of Corporate Patrons and/or their possessions is required at the time of entry to Tropfest 25. Refusal to consent to a search will prevent entry to Tropfest 25, without refund.
- f. Glass, alcohol, weapons, illegal substances or any item Tropfest considers may be used in a dangerous or offensive manner may be confiscated and not returned and such persons possessing the confiscated items will be refused entry or evicted from Tropfest 25.
- g. Entry is at the Corporate Patrons own risk and the right to refuse entry is reserved. Tropfest shall not be held liable for any loss, injury or damages sustained entering on the site.
- h. Professional audio or visual recordings of Tropfest 25 are prohibited.
- i. By attending the Event, You and Your Corporate Patrons consent to being included in any film and/or sound recordings of Tropfest 25 that may take place and agree for these recordings to be used by Tropfest.

4. Liability

- a. To the fullest extent permitted by law, the total liability of Tropfest for any and all claims is limited in the aggregate to the total amount of fees paid under the Agreement. Tropfest does not accept liability of any nature for the acts, omissions or default of those providing services in connection with Tropfest 25 or any liability for any injury, damage, loss, delay or additional expenses which are incurred at or in association with Tropfest 25.
- b. Admission is at Yours or Your Corporate Patrons own risk. You and Your Corporate Patrons acknowledge that Tropfest will not be responsible for any loss or damage to property (including personal property such as bags, money or other personal items) brought to or purchased at Tropfest 25.
- c. You will be liable for any loss or damage caused at Tropfest 25 by Your Corporate Patrons, invitees or any persons who are in the Contracting Parties corporate hospitality venue.

5. Consumption of Alcohol and Smoking

- d. Only certain areas are permitted for alcohol consumption. Alcohol consumption in areas where alcohol consumption is not permitted, will result in immediate eviction of the persons in breach.
- e. Any person wishing to consume alcohol must have photographic ID. Tropfest reserves the right to evict patrons who are disruptive and/or break the responsible service of alcohol legislation and the law.
- f. Any person found supplying or buying alcohol for a minor will be evicted from Tropfest 25.
- g. Smoking will not be permitted at Tropfest 25.

6. Privacy

You acknowledge and agree (and will ensure that its representatives are notified or made aware) that Tropfest may collect, use, hold and disclose personal information collected from You, Your Corporate Patrons or other persons in relation to the Agreement in accordance with the Tropfest Privacy Policy.

7. Governing Law

This Agreement is governed by and is to be interpreted according to the laws in force in New South Wales, Australia. The parties submit to the non-exclusive jurisdiction of the courts operating in New South Wales, Australia.

8. Definitions

In these terms and conditions the following words and expressions have the meaning shown unless the context requires otherwise: **Agreement** means the combination of any Booking Form and these Terms and Conditions and any other documents forming part of the Agreement specified in the Booking Form. **Booking Form** means the Corporate Experience Booking Form which these terms and conditions apply to. **Contracting Party, You and Your** refers to the customer specified in the corporate hospitality booking form. **Corporate Experience Option(s)** means the selected Corporate Experience as selected in the Booking Form. **Corporate Patrons** means any persons who attend Tropfest and access the corporate hospitality marques and other related areas. **We, us, our and Tropfest** refers to Tropfest Australia Limited ABN 13 613 633 533 its employees, contractors, volunteers and authorised persons.
